Maria S. Floro is Professor Emerita of Economics at American University in Washington, DC. She served as co-director of the Graduate Program on Gender Analysis in Economics (PGAE). Her publications include books on *Informal Credit Markets and the New Institutional Economics*, *Women's Work in the World Economy*, and *Gender, Development, and Globalization: Economics as if All People Mattered* (co-authored) as well as monographs and journal articles on gender, vulnerability, informal employment, food security, care work, time use and well-being, and climate change. She collaborated in early 2000 with researchers, women's groups, and community organizations in Thailand, the Philippines, Ecuador, and Bolivia in conducting fieldwork on vulnerability, gender, and informal employment in urban poor communities. She led the Care Work and the Economy (www.careworkeconomy.org) project.
