## COURSE DESCRIPTION

This course deals with new and more advanced developments in the international trade related rules and regulation. Based on fundamental knowledge on international trading system, this course will cover divergent "new" trade issues with increasing practical importance. Each topic area such as service trade, intellectual property protection, and FTA will be supplemented by selected case studies that are real WTO disputes.

Any questions regarding the class materials or other relevant issues are welcomed at my office hour [Tuesday 1:00-2:00, or by appointment] or after each class.

The final assessment for the course will be based on a take-home examination. Class participation, weekly case summary and case presentation will be favorably considered in your final grade up to 40%.

#### COURSE OUTLINE

The required textbook is P. van den Bossche & Werner Zdouc, Law and Policy of the World Trade Organization (4th ed. 2017) will be used as a supplementary (optional) textbook.
