CAMPUS Asia: An Overview

Collective Action for Mobility Program of University Students in Asia (CAMPUS Asia)

- ❑ CAMPUS Asia Project is a undergraduate- and graduate-level dual degree program among universities of Korea, China and Japan.
- ❑ CAMPUS Asia Project aims to nurture future leaders of East Asia with global competence and thorough understanding of East Asian values.
- ❑ CAMPUS Asia Project also seeks to serve as a window for developing practical measures to overcome regulatory and administrative differences that hinder academic and student exchange.
- ❑ Driven by a strong commitment to establish an East Asian academic community, CAMPUS Asia strives to deepen mutual understanding among Korea, China, and Japan, and eventually ASEAN countries thereby paving a new path for East Asian regional integration.
- ❑ Ten consortia have been selected to take part in the CAMPUS Asia program in October 2011.
- ❑ Host universities provide students with monthly stipends;
Graduate students receive KRW 900,000, RMB 1,700 or JPY 80,000 and on-campus housing.

- By combining curricula with different fields of concentration, BESETO is designed to enrich and broaden students' scope of knowledge in regional and international studies.

Degree Tracks

- Exchange Student: 1 + 0.5 + 0.5

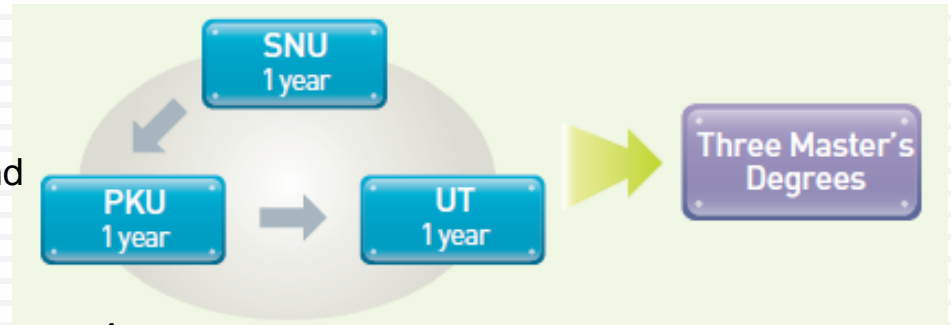
- Degree will be awarded from home institution (e.g. Seoul National University) and a certificate will be given from each partner institution after studying one semester at each institution (e.g. Peking University and The University of Tokyo).

- Dual Degree: 1 + 1 + 0.5

- First degree will be awarded from home institution (e.g. Seoul National University) and second degree will be awarded after studying a year at a partner institution (e.g. The University of Tokyo). A certificate will also be given after studying one semester at another partner institution (e.g. Peking University).

- Triple Degree: 1 + 1 + 1

- A degree will be awarded from home and each partner institution (a total of three institutions) after studying one year at each institution.



Dual Degree Track

For example, a student from UT pursuing dual degree track at SNU will:

- ▣ Get tuition waiver at SNU for a full academic year;
- ▣ Receive monthly stipend (KRW 900,000) during his/her stay at SNU;
- ▣ Be exempt from taking some core courses at SNU depending on courses obtained at UT according to the core course mapping module;
- ▣ And be expected to meet the requirements for graduation at SNU (i.e. foreign language proficiency, thesis qualifying exam, thesis proposal and submission, etc)

Additional Programs

- ❑ Language Programs (Korean, Chinese, Japanese)
 - ❑ Korean: Language Education Institute (LEI) at SNU
 - ❑ Chinese: School of Chinese at PKU
 - ❑ Japanese: Language courses at Graduate School of Public Policy, UT

- ❑ International Summer School
 - ❑ Each partner institution takes turn in hosting a two-week intensive summer session which involves students and professors of all three institutions in lectures and seminar sessions. The objective is to enable active multi-party discourse and comprehensive understanding on current regional issues.
 - ❑ CAMPUS Asia Summer School
 - ❑ SNU: August 1st~14th, 2012 and June 25th~ July 25th, 2013
 - ❑ UT: July 29th~August 10th, 2013
 - ❑ PKU: Expected to host in August, 2014

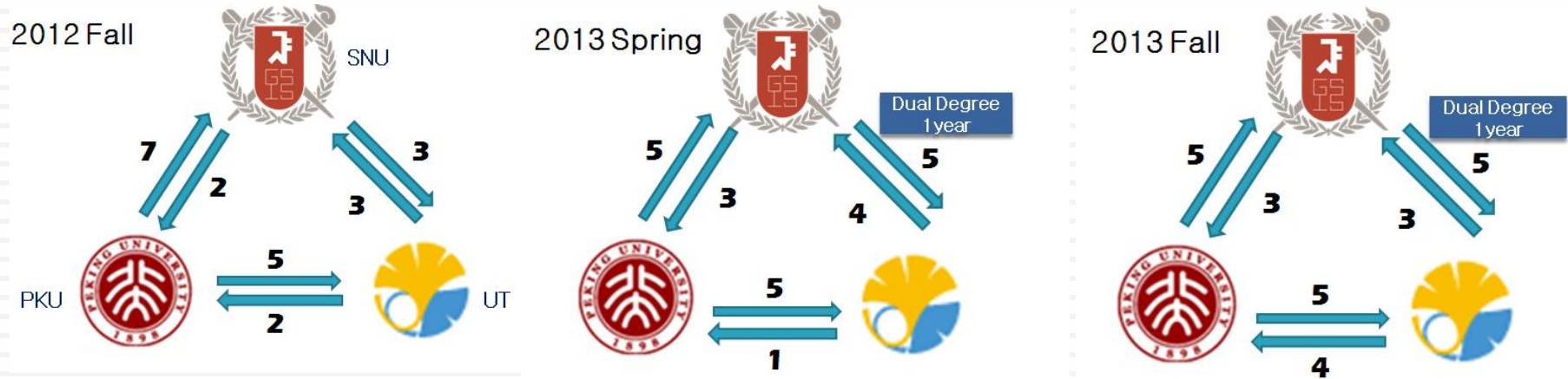

Expected Effects

- ❑ Establishing a hub for international research and education regarding East Asian Studies
- ❑ Contributing to East Asian Regional Integration
 - ❑ Comparing pending issues and policies that the core countries of East Asia: Korea, China and Japan, currently face and linking East Asian integration issue to research and education for further mutual understanding
- ❑ Providing Practical and Working-Level Education
 - ❑ As opposed to simple academic exchange, encouraging cultural understanding between the three countries and emphasizing both practical and working-level education, thereby preparing students for the job market in those countries
- ❑ Strengthening East Asian cooperation by providing an opportunity for a multi-academic and multi-cultural exchange
- ❑ Contributing to academic development through active exchange among professors and graduate level students from the three countries
