D. Institute of International Affairs (<http://iia.snu.ac.kr>)

As Korea's primary research center for International Studies, Institute of International Affairs (IIA) takes a role of conducting research and expanding materials related to International Commerce, International Cooperation, International Area Studies, and Korean Studies. Most of the Institute's activities support academic exchanges with other researchers, governments, and corporate institutions worldwide and publish annual reports, journals, and working papers for international research. Under the patronage of SK Corporation from 2019, IIA was reformed, recruiting more researchers, providing independent space for IIA under Graduate School of International Studies (GSIS), and reorganizing the centers under IIA into 10 research centers in order to help raise expertise concerning the issues on international and area studies. Starting with 'the Opening Ceremony of the Institute of International Affairs, Seoul National University' and 'Vision Proclamation Ceremony & Celebration Symposium' which are held on early 2020, IIA will take a leap to one of the global outstanding institutes for international and area studies. IIA is expected to promote academic exchanges among the GSIS faculty and researchers specialized in international studies both at home and abroad, do publication including the regular Issue Brief and Global Strategy Report regarding the issues on international and area studies in both Korean and English, and hold a distinguished regular seminar and academic conference locally and abroad. In addition, IIA plans to train the next generation and do IIA Bookclub to contribute to the Society.

1) Center for EU Studies

The Center for EU Studies is the first specialty research center established with the support of the European Commission under the Institute of International Affairs. It takes a role of showing what EU does and What activities EU do via educational program and research. In addition, the Center for EU Studies was awarded by the European Commission as a 'Center of Excellence' in South Korea since 2011. Carrying on South Korea-EU Education Cooperative Project for the first time to make an intimate relationship between South Korea and EU, CEU is now truly the most leading EU research institute in South Korea.

2) Center for International Development Studies

The Center for International Development Cooperation promotes international development by engaging in diverse research activities and global interaction and cooperation with various levels of actors of international development from advanced and developing countries. The research focuses on development issues covering all regions and time. Based on such a broad set of research activities, it provides insights and outlook for development for all actors of international development who want to plan and implement strategies for development. The CIDC plants the seeds for a better world.

3) Center for International Security

The center for International Security focuses on presenting objective assessment and practical perspective on security issues complicatedly mingled in the changing world order. Newly established in 2019 under Institute of International Affairs, CIS conducts research to improve strategic thinking and understanding in academic and policy-level

viewpoint as the security uncertainty get raised in this US-China Strategic Competition.

4) Center for Transnational Migration and Open Society

The Center for Transnational Migration and Open Society focuses on academic research and cooperation among academia, civic organizations, and the government to make a nondiscriminatory society based on gender, ethnicity, age, and disability, improve the right of the disadvantaged and contribute to the development of the open society.

5) Center for International Commerce & Strategy

Since the establishment in 2013, the Center for International Commerce & Strategy have managed all processes of holding seminars, academic conference and education program related to international commerce on campus, under the lead of the director and the chief professor.

6) Center for International Cooperation

The International Cooperation Research Center is a research center that analyzes issues on international security, international law, international organizations, international development, international political economy and global governance in a rapidly changing global environment. The center covers all aspects of Northeast Asia security issues, global climate change, developing countries' development problems, international legal solutions to international disputes, and conducts research on political response strategies to international issues.

7) Center for East Asian Studies

The Center for East Asian Studies embraces major issues on security orders, political systems, economic systems, and civil society to enhance interdisciplinary and comprehensive understanding on East Asia. Beyond the perspective based on the Korean Peninsula and East Asia where the Cold-war security order continues, CEAS focuses on various non-security-related conflict and dispute factors which currently exist and lie dormant in East Asian area, and makes effort to research and make policy for co-management, which can achieve peace and prosperity through intensified economic interdependence, exchange and cooperation.

8) Center for American Studies

The Center mainly conducts studies on economic and political issues in North and South America. The research carried out so far has mainly been focused on free trade agreements between Korea and Latin American countries, other economic

cooperation measures, and South Korea's development cooperation policy toward Latin American countries.

9) Center for Chinese Studies

The Center for Chinese Studies analyzes major issues deeply and suggests rational policy alternative for an in-depth international and areal understanding on China. It captures accurately how modern China changes with both internal and external perspective, and makes an effort to build a platform for systematical and sustainable research on China.

10) Center for Korean Studies

The Center for Korean Studies was established for the purpose of enhancing the capacity of Korean Studies research and expanding the network of scholars in the discipline. The Socheon Center opened in June 2013 with the generous support from Madam Socheon Young hi Park, who has worked for the development of Korean Studies throughout her lifetime. In addition to fostering academic research and hosting colloquiums, the Center held the 12th World Korean Studies Consortium Workshop in June 2016 to promote interaction among the Korean Studies scholars from leading universities worldwide. The Socheon Center also organizes diverse cultural experience events to give opportunities for foreign students to experience and learn about Korean traditions.

E. Institute for Japanese Studies (<http://ijs.snu.ac.kr>)

Institute for Japanese Studies is an interdisciplinary, in-depth research institute for modern Japan. Through the network of Japanese researchers both on and off-campus with six full-time faculty members. IJS focuses on joint research, Japanese data collection, various academic projects such as international conferences, construction of information network, as well as research, academic, and social contribution projects to nurture next-generation Japan experts.

In research activities, IJS focuses on research that can link the elements of past and present while highlighting the present rather than the past, interdisciplinary research that combines humanities and social sciences, and empirical research that emphasizes the field. The scope of the institute is not limited to these research and academic activities. It not only concentrates in fostering the next generation of Japan experts, but also in social contribution activities as the institute is aware of practical implications of its activities.

IJS is now taking a new leap forward with Humanities Korea+ (HK+) projects under the agenda of "Japanese Life-World in the Era of Post-Area Studies: Maturity and Change, Crisis and Solidarity" for seven years since 2019. The institute will create new knowledge and discourse in the field of Japanese research based on

existing research results and contribute to peace and common prosperity in East Asia by establishing desirable relations between Korea and Japan. IJS will also continue to strive for the development of new areas and research models in Japanese studies.

1) Seminar Rooms (Master)

As the seminar rooms are located next to the study room for the Ph.D. students, we advise you to have discussions at a reasonable volume level. (140 Building #303, #304)

2) Seminar Rooms (Ph.D.)

The study rooms for doctoral student are located on the 3rd floor (#301, #302, #308) of 140 Building.

3) Study Rooms

The largest room on the 3rd floor (#309) of 140 Building, which can accommodate around 30 students. The study room is a quiet room and offer separate lights and power plugs to recharge your laptop or any other devices. Please keep quiet in this room to not disturb other students.

4) Student Lounge

The student lounge is located right next to the study room (140 Building #310). It has couches, tables and a vending machine for drinks and snacks, so that students can enjoy a study break.

5) Student Council Room

The Student Council room is located opposite of the Student Lounge and has an *open-door policy (140 Building #305)*. If a member of the student council is present in the room, any student can go in and ask questions, voice concerns, or just enjoy some coffee.

H. Other Facilities

The GL-Room (Global Leaders' Room) is located on the 2nd floor of Building 140.

Equipped with the latest audio-visual presentation equipment and an accommodation capacity of 60 people, the Global Leaders' Room is available for special lectures and ceremonies. The So-Cheon International Conference Hall and International Conference Hall are used for major ceremonies and international conferences.

The So-Cheon International Conference Hall is located on the 1st floor of Building 140 and the International Conference Hall is located on the 4th floor of Building 140-2. Students who wish to use these facilities should apply to the administration office in advance.

III. Academic Requirements

A. Requirements for Graduation

[Master's Program]

A minimum of 39 credits is required for graduation (including a minimum of 9 credits from Practical Courses). GPA of 3.0 or higher out of 4.3 is required.

2) Students should take at least 3 courses (9 credits) in their GSIS major program.

* You can choose major courses from other majors that are mutually recognized majors. (Refer to Mutual Recognition List)

3) Students must take courses (credits) to fulfill required credits (39 credits) to be eligible to graduate.

4) Students must take at least 3 courses (9 credits) from practical courses in their major or elective program.

5) Students can take undergraduate courses (Elective Subject for Major or Requisite Subject for Major) within 6 credits. Students should seek advice from their advisory professor before registering for an undergraduate course.

[Ph.D. Program]

A minimum of 45 credits is required for graduation.

- (1) Students must take one research method course (Those who have already taken a methodology course in their Master's program are exempted).
- (2) Students should take 4 courses (12 credits) or more from their major program (International Commerce, International Cooperation, and International Area Studies)
- (3) Students should take 3 courses (9 credits) or more from other major programs (International Commerce, International Cooperation, International Area Studies,

and Korean Studies).

- (4) Students should take at least 8 elective courses (24 credits), including "Dissertation Research" (Students taking methodology course should take at least 7 elective courses (21 credits) or more)

* "Dissertation Research" is not mandatory for students in the doctorate program. However, students may take the course up to 4 times (a maximum of 12 credits, one course per semester) and have it counted as credits required for graduation.

- Students who earn at least 3 credits in foreign language courses and receive a B0 or higher, may be exempted from taking the language test on their qualifying examinations. (Note: Students who take foreign language courses during their study abroad programs may be exempted from taking the test on their qualifying examinations, but will not be allowed to transfer their credits for those courses.)
- Students who have passed SNULT Level 3 or higher are exempt from the second foreign language requirement.

- Students who take courses in 'French (104.811)' or 'German (105.811)' and receive a C- or higher, are exempted from taking the respective language tests on their qualifying examinations.
- To meet the Korean language requirement, international students must score sixty points (60) for master's program, seventy points (70) for doctoral program, or higher on the Korean language test. However, students who had received an "S" in their "Korean language and Culture 1 (Course No: 990.804)" or "Korean Language and Culture 2 (Course No: 990.805)" are exempted from taking the Korean language test.
- Korean Examination: Students can take Korean written examination (Students who fail the written examination more than once can substitute by taking an oral examination).
- Students of Development Cooperation Policy Program(DCPP) can select Korean language for their qualifying examinations.
- English speakers include students who use English as an official language.
- Student can take the Language courses for the qualifying examination but it will not be included in official credits for graduation.
- Students may submit language test score (taken within the last two years) to meet their foreign language requirement. Language tests recognized by GSIS are indicated below.

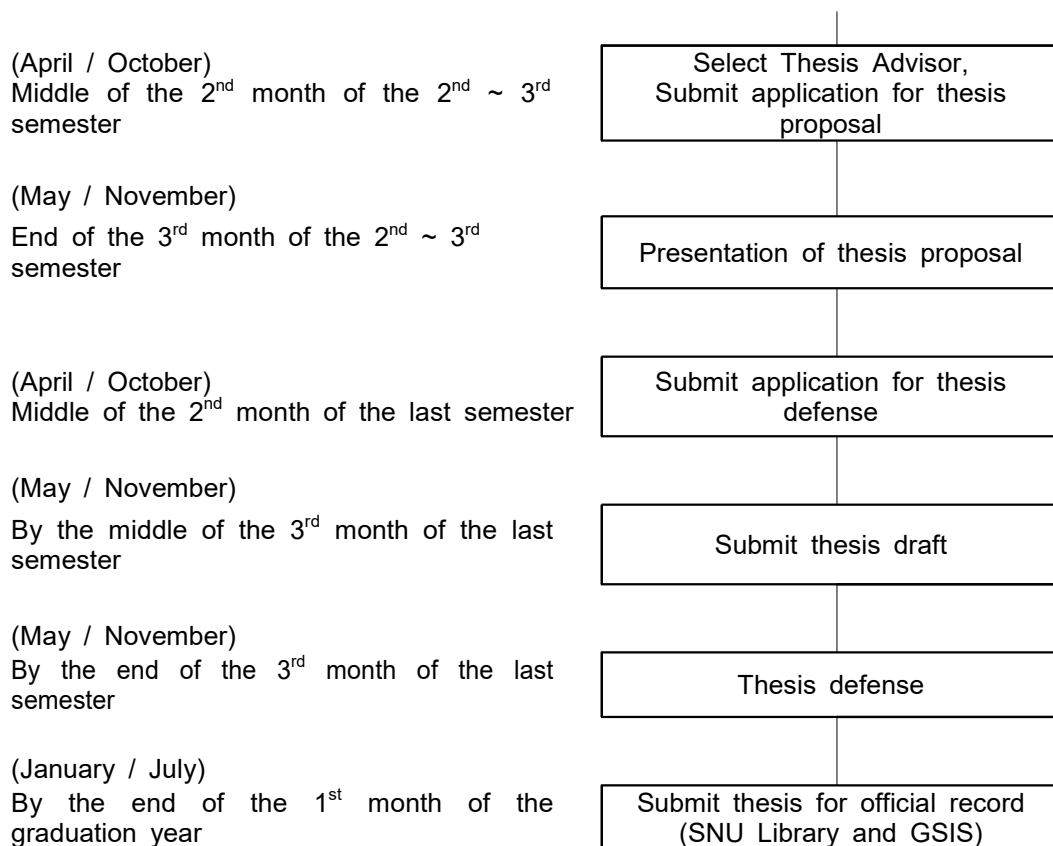
- Prior to thesis defense, candidates should have one or more articles published in a scholarly journal (double blind peer review academic journal) as the author or primary author of two authors or corresponding author).
- Frequency of Application: Candidates are not allowed to apply for thesis qualifying exam more than 4 times. Candidates can apply for 3 sections at a time.
- Application Period: Within 8 semesters after enrolling (excluding leave of absence)
- Students must score seventy points (70) or higher on the each course test.

C. Application Procedure for Thesis

(Planning to graduate within 4th Semester)

Students are eligible to apply for taking the examination as of their 2nd semester.

- Students cannot submit their thesis proposal and do the defense in the same semester.

- The title of the thesis must be equivalent to the title and subtitle agreed upon by the Thesis Committee.

Students are granted a **Master of International Studies**, with a major field of study specified.

[Ph.D. Program]

Students are granted a **Doctor of Philosophy in International Studies**.

IV. Scholarships

A. Scholarships Available for GSIS Students

- 1) SNU Scholarship: Partial exemption of tuition
- 2) Working Scholarship: Hourly wages for work as assistants
- 3) SNU Foundation Scholarship: Sponsored by SNU Foundation (each with different eligibility conditions)
- 4) Scholarship for Teaching Assistant (TA): Exemption of full tuition and a monthly allowance
- 5) Socheon Scholarship, GLP Scholarship: Sponsored by the Socheon Foundation and Global Leadership Program
- 6) Global Scholarship: Full tuition fee for international students. Has different application procedure from SNU scholarship.

B. Scholarship Application

For scholarship application, students should check scholarship notices from Official Notice Board of the GSIS website and submit required documents to the GSIS administration office. **(Scholarships can be awarded to those who applied for it.)** Scholarships are awarded based on a student's GPA, financial situation and other criteria. A student is eligible to apply for a scholarship if he or she has taken 9 credits or more (excluding Dissertation Research) and has received a GPA of 3.3 or higher (3.0 or higher for international students).

V. Registration Information

A. Course Registration

Registration notifications are posted on the GSIS homepage. Students are expected to register for courses through the on-line course registration process (<http://sugang.snu.ac.kr>).

- 1) Students wishing to enroll for courses should be fully aware of Seoul National University's rules for registration. To view the full text of these rules, visit SNU's homepage (www.snu.ac.kr).
- 2) Before enrolling, students should first read a notice from the Administration Office. Students must enroll for courses within the set due date and receive confirmation from an academic advisor. Student can get administrative assist at the Office in enrolling.
- 3) When re-taking a course or registering for a double-titled course (a course number with a * mark preceding it, such as *8752.616), please pay attention to whether it is a different course or a replaceable course (if it is a replaceable course, it is considered the same course as the one it is meant to replace).
- 4) Any problems that result from a mistake made during course registration will entirely be the responsibility of the student. Therefore, students should carefully review registration guidelines and receive instructions from an advisor, if necessary.
- 5) If a student wishes to take undergraduate courses, he or she may take up to 6

credits with the approval of the head professor in his or her major program. However, please note that no undergraduate general courses are eligible for credit transfers. (Only major courses are eligible for credit transfer.)

B. Leave of Absence

A leave of absence is classified as either a general leave (leave taken by not registering during the registration period), or a semester leave (leave taken before the end of the 2/4 of the semester). In case of a semester leave, students can transfer tuition fees to next semester only when they apply for the leave before the end of the 2/4 of the semester. However, in case of illness or military service, students can apply for leave even after 2/4 of the semester, and can transfer tuition fees to a future semester. A general leave of absence automatically expires after 2 semesters (except in case of Military Service Leave of Absence and other cases specified). The minimum length of a leave of absence is limited to one semester. The aggregated term of absence cannot exceed four semesters for graduate students in a master's program, and six semesters for students in doctoral program. Student can apply through mySNU site (<http://my.snu.ac.kr>).

C. Re-enrollment

Students who wish to re-enroll can apply through mySNU site (<http://my.snu.ac.kr>) during the registration period. In case of returning after completing military service, students must submit a resident registration certificate (stating their military status) or a certificate of military service discharge.

D. Student Identification Card (S-card)

Check the official notice of student identification card posted on the GSIS homepage (<http://gsis.snu.ac.kr>) each semester.
S-card may take the form of a smart card with an integrated function containing ID and banking services.

VI. GSIS Exchange Program

A. Studying Abroad

1) Prerequisites for Studying Abroad

- a) Students must submit an application form after getting approval of academic advisor and chair (academic associate dean) to the GSIS Administration Office.
- b) Students must apply three months prior to the beginning of the regular semester and two months prior to the beginning of winter and summer sessions.
- c) Students may study abroad for up to one year and earn a maximum of 12 transfer credits per regular term and 9 transfer credits per winter/summer term.

2) Changing or cancelling application

Students must submit the necessary forms to the GSIS Administration Office.

3) Transfer Credits

- a) After completing the study abroad program, students must submit a transcript

from the university at which they studied abroad and a GSIS application form for transferring credits to be approved by the GSIS administration office. With approval by an academic advisor and a chair (academic associate dean) and a member of the academic committee, the final credits will be confirmed.

- b) Although grades from studying abroad will be shown in the transcript, they will not be included in the student's overall GPA. However, in case of dual degree programs, grades acquired at the foreign university will be included in the student's overall GPA.
- c) One credit requires 15 or more hours per semester.
- d) Language course credits cannot be transferred.

B. Exchange Program

1) Qualifications

- a) Student must have enrolled in GSIS for at least 1 semester and completed at least 2 semesters before going abroad with the exchange student program
- b) GPA of 3.3 or higher (GSIS grades)
- c) A TOEFL score by IBT-TOEFL 94 or higher
 - * Students applying to a non-English speaking university must meet proficiency requirements of the language.

2) Required Documents

- a) Application form: 1 page (GSIS form)
- b) Study plan: 1 page (GSIS form)
- c) Resume: 1 page (GSIS form)
- d) A copy of GSIS transcripts
- e) A copy of TOEFL score report
- f) A letter of recommendation written by his/her academic advisor (GSIS form)
- g) Written oath

3) Application Due Date

- a) The application for exchange program is due in mid-February for every fall semester, and mid-August for the spring semester. All documents should be submitted to the Office of International Cooperation. (Bldg.140-1, Room 301).
- b) Students will be notified at the end of March for the fall semester, and at the end of September for the spring semester

4) Credit Transfers

- a) Students may obtain a minimum of 9 credits per semester.
- b) For summer sessions, students may obtain a minimum of 6 credits.
 - * In principle, one credit accounts for 15 class hours.

5) Tuition Fees

- a) Students are required to pay regular tuition fees to SNU.
- b) If the host university is on a trimester system, GSIS tuition for one semester covers tuition costs for two trimesters at the host university.

6) Others

The Exchange Program intends to provide opportunities for students without much international experience studying abroad. Hence, students with little or no international

experience will be given priority.

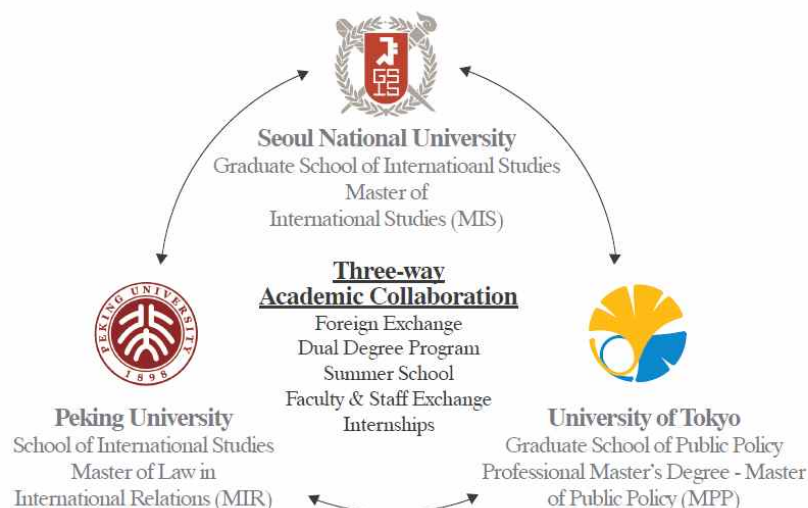
1) Outline

Students who are admitted to participate in the Three-way Dual Degree Program by Seoul National University, Tokyo University, and Peking University, will be exempted from the tuition fee of each university and receive a scholarship that partially covers living expenses.

2) Basic Module

Students will receive their Dual Degree after studying at both the Home University and the First Partner University, for 1 year at each university. A certificate of attendance will be given to those who studied an additional semester at a Second University as an exchange student.

B. Housing and Meals

Students may choose to live in a university dormitory, rent an apartment, or lease a room in a boarding house near campus. Dormitory (Kwanak-sa) application procedures are posted on the campus housing website (<http://dorm.snu.ac.kr>) in May and November of each year.

Students who wish to apply to live in the BK International House must apply online at mySNU site (<http://my.snu.ac.kr>) and submit the required form to the Administration Office of GSIS (Bldg. 140-1 #301) with his or her alien registration card (or passport).

Kwanak-sa (dormitory) Administration Office: Building #900, B1F (Tel: 880-5403 /4)

Students are free to use restaurants and cafeterias located on campus. (Bldg. 220, College of Human Ecology/ Bldg. 74, Yesulgye Restaurant, Bldg. 113) When having meals in campus restaurants or cafeterias, students can pay with a debit or credit card and can receive a student discount if they register their card (usually at the entrance of the cafeteria).

C. Transportation

If coming to SNU by subway, get off at “Seoul National University” or “Nak-Sung Dae” station (Line No.2).

From the “SNU” station: Take exit No. 3 and take Bus #5511 at the nearest bus stop. This bus stops in front of the GSIS building. If taking a taxi from the station, the fare is approximately 5,000 won. You may also take any bus that stops at the Main Gate of SNU. GSIS is about 15 minute walking distance from the Main Gate.

From the “Nak-Sung Dae” station: Take exit No. 4, and take “Ma-eol bus (마을버스)” No. 2 at the nearest bus stop. Get off at the Dorm Crossroad (기숙사삼거리) and walk about 5-10 minutes down the hill to GSIS.

D. SNU Health Service Center

HSC offers basic medical consultations, health check-ups and vaccinations. It is located on the 3rd floor of the Student Union Center (학생회관).

E. National Health Insurance (International Students)

International Students can register for the National Health Insurance and enjoy the benefits of insurance at hospitals in Korea. (<http://www.nhis.or.kr>)

F. Bookstore

Students may purchase Korean or foreign books at the bookstore located on the second floor of the Student Union Center. (학생회관)

G. Others

Students may use the Portal site (my.snu.ac.kr) to register for classes, check their grades, check tuition fees, or apply for scholarships. Updated announcements on GSIS are also posted on the Official Notice of the GSIS homepage (gsis.snu.ac.kr -> News & Events -> Official Notice)

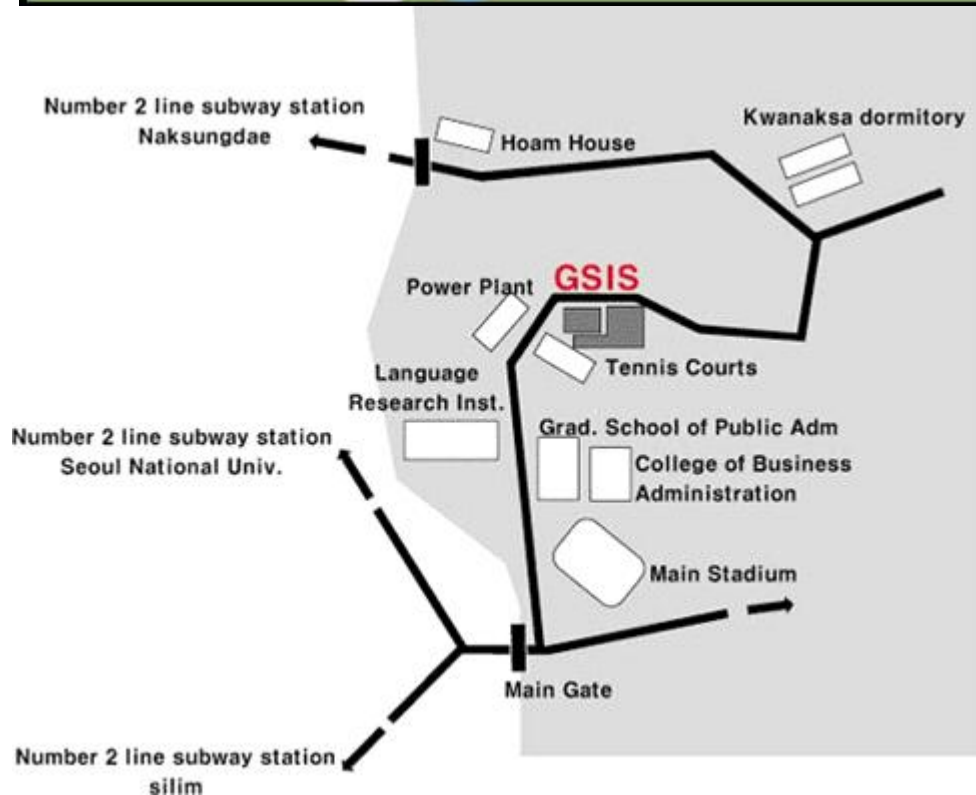
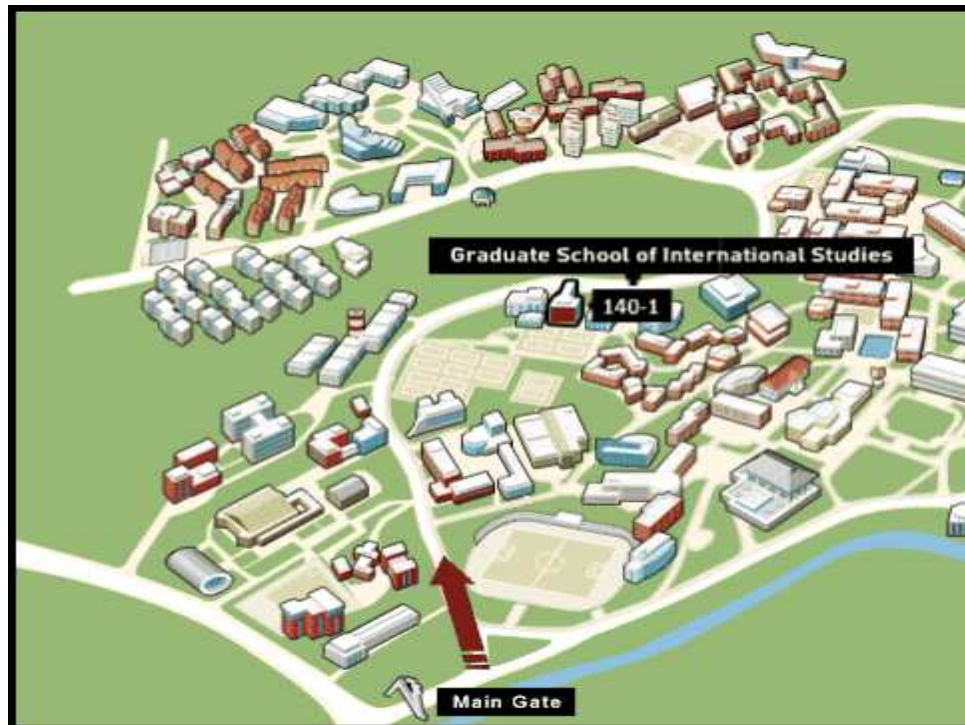
