Course Description

This seminar provides an intensive study of contemporary Korea-Southeast Asia relations in economic, security, and cultural domains. In doing so, it pays great attention to how general theories of international relations, political economy, and development studies can be fruitfully applied to the study of the interactions between Korea and Southeast Asia. Equally importantly, this course is also designed to equip students with abilities to work seriously with both qualitative and quantitative data while informed by historical understanding of these relationships. Students will be asked to gather, describe, and analyze data to gain insights on Korea-Southeast Asia relations.

Course Prerequisites

There are no prerequisites although Korean reading proficiency will help you extract statistical data from Korean sources.

- 1. Attendance and participation: Students are expected to do the readings before they come to class and engage discussions.
- 2. Weekly response questions: Students will submit questions on the weekly readings. Those questions will be discussed in class and evaluated by the instructor.
- 3. Assignments (three projects): Students will compile (1) a cross-country comparison of key economic indicators of Korea and Southeast Asian countries, (2) an annotated timeline of Korea-Southeast Asia relations, and (3) an analysis of international treaties between Korea and a Southeast Asia country.

For assignments involving data collection and data analysis, you will be asked to work with MS Excel and Tableau. Detailed instructions will be provided at the beginning of the semester.

- 4. Student presentations: Students will present their work on the bilateral relations between Korea and a Southeast Asian country to class near the end of the semester. Detailed instructions will be provided at the beginning of the semester.
- 5. Final exam: Students will take a take-home exam. Detailed instructions will be provided at the beginning of the semester.

There is no single text for this course. For journal articles, students are expected to obtain them through the SNU library system. Reading materials that may be difficult to find will be available through ETL.
