Guest lecturer: Sasano Misae (PhD Candidate, Sociology Department, SNU)

How do Japanese women's life courses have in common with Korean women, and how are they different? We will read two papers that attempt to explain Japan's demographic, family and women's life course changes from different perspectives. Emiko Ochiai is looking for an explanation of East Asian demographic and family changes, focusing on the timing and speed of modernization based on the demographic transition theory. On the other hand, Toru Suzuki, a demographer, tries to explain from the viewpoint of cultural theory (explained by Confucianism and Feudalism), the appearance of the family before modernization. Comparing two perspectives, we will think comprehensively about the family and women's life course changes in Korea and Japan.
