■ COURSE DESCRIPTION

This course is about technical barriers to trade (TBT), i.e. trade barriers arising from technical measures that typically include technical regulations, standards, and conformity assessment procedures. Since the technical measures pursue legitimate public policy objectives such as protection of human, animal and plant life or health, regulating them under the world trading system requires a careful balancing between state's regulatory sovereignty and expansion of free trade. In addition, their various forms and complexity often challenges general rules applied under the GATT/WTO system. The objective of the course is to introduce to students basic knowledge required to analyze non-tariff barriers in general and TBT in specific with multidisciplinary approaches.

The course is divided into two parts: it explores technical measures and their relevant trade rules. The first part is designed to help students understand nature and characteristics of technical barriers and covers concepts, theories and exemplary cases. The second part introduces TBT mechanisms under the GATT/WTO system and major FTAs, TBT dispute resolutions, and regional and national strategies to reduce the barriers. There is no pre-requisite; previous study of trade rules, public policy will be helpful.
